**Approve Purchases for Ag Program Using CTEIG Funds**

The District requests approval of the following items for the Ag Program:

- 1) Approve purchase of a utility vehicle (side-by-side), not to exceed \$16,000, paid with CTEIG funds
- 2) Approve purchase of a forklift, not to exceed \$30,000, paid with CTEIG funds
- 3) Approve purchase of shop software for the plasma cutting machine, not to exceed \$9,000, paid with CTEIG funds
- 4) Approve purchase of permanent gas bottles, not to exceed \$3,000, paid with CTEIG funds

The sum total of these items are not to exceed the entire CTEIG budget.
